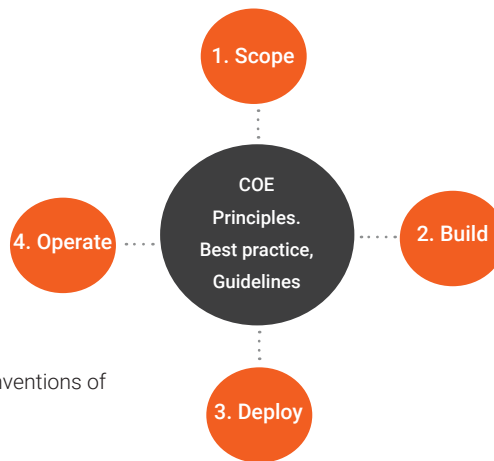

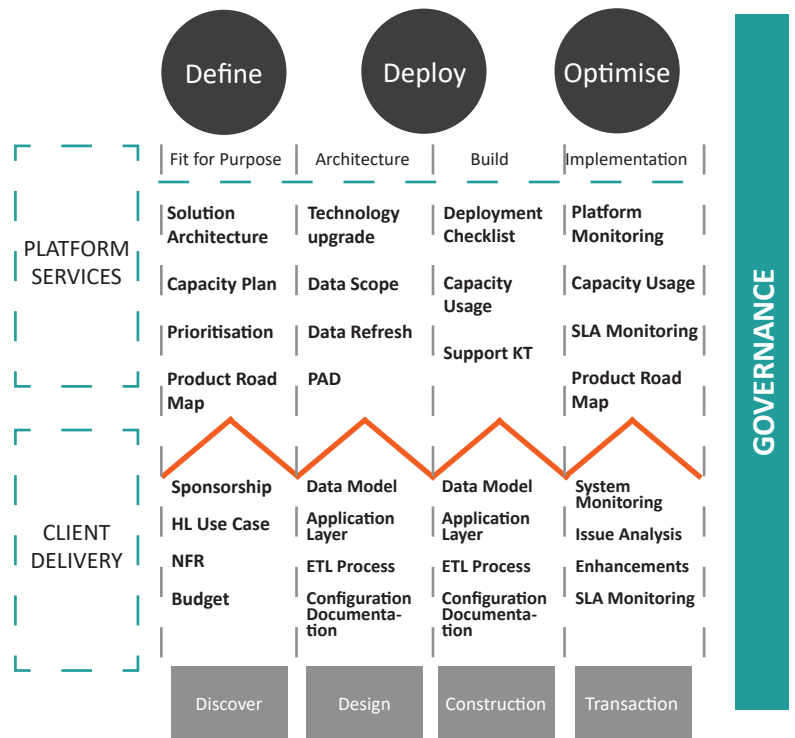

BI/DW Program Delivery at a Tier 1 Investment Bank

- emagine architected a technical solution that delivered an ETL-data warehouse-MDM Reporting programme which integrated sub-ledger, P&L, Risk, HR, external data, and Reference Data on Informatica, Oracle warehouse, DRM, Essbase, Cognos/ QlikView, as well as Liferay technologies which delivered an initial release in only four months.

LGD Program for a Tier 1 Investment Bank

- emagine's client needed to deliver the Probability of Default (PD) and Loss Given Default (LGD) information for UK commercial customers to evolve a global solution for all relationship managers. emagine worked with stakeholders to conceptualise the solution components which integrated internal trade details with client specific financial details and industry-specific indices through data integration, statistical/analytics model and visualisation layers.

Risk and P&L

Strategic IPV Reporting at a Tier 1 Investment Bank

- Global Valuations Group (GVG) required a single analytic platform to support daily, mid-month and month-end IPV processes, reviewing IPV results, including scenario testing, architected design and delivering 9 operational analytics applications. The QlikView onshore/offshore team delivered management control on position testing, valuations and provisions, including pricing framework and decommissioned EUDAs.

- The existing P&L reporting solution through Essbase and Cognos technologies lacked fundamental analytics capability for daily and monthly P&L processes. emagine designed and delivered separate daily and monthly P&L analytics applications using QlikView technology providing executive dashboards and analytics capabilities for senior management.
